Application for refund of customs duty on goods declared under the procedure of release for free circulation using the Norwegian Customs app

If you have used the Norwegian Customs app and believe you have paid too much in customs duties, you can apply for a refund. For evidentiary reasons, Norwegian Customs can only refund the amount if you contact customs officials in the red zone when entering the country. You must fill out this application form and have it certified by an official.

If you can document that too much customs duty was paid due to a technical error during the payment process, you can apply for a refund regardless of whether you reported it in person. In such cases, Norwegian Customs will request information on what went wrong and assess each case individually.

The refund application will be processed by the Movement of Goods Division, which will pay the amount to your bank account. You will not receive the refund in cash.

Pursuant to Section 11-1 of the Customs Duty Act, a refund is requested for an overpaid customs duty resulting from the use of the Norwegian Customs app for declaring travel goods under the release for free circulation procedure.
